COMPLAINTS AND PROTESTS

Define deadlines if different to the ones described in Section 7A 9.8.8. As per Section 7 and 7A.

If the competitor is not satisfied with the judgment of his claim, he may submit a written protest to the General Judge. Protests must be submitted within a maximum period of one hour after the notification of the result of the claim by the General Judge, upon payment of the fee of R\$ 150.00.

On the last day of the competition, protests must be submitted within the maximum period.

20 (twenty) minutes after notification of the result of the claim by the General Judge. The General Judge will forward the protest with the history of the complaint and its decision to the Protests Committee, which will handle the case sovereignly, being able to decide for the fee refund.

The Protest Committee will be composed of 03 (three) full members plus 03
